# 1. <u>SITUATION</u>

a. 223 Red Lion Air Cadets level one and above will be participating in a level one field training exercise, to teach and broaden information on basic survival techniques. It will be conducted at Cottonwood Beach, Mabel Lake BC. This exercise will commence at 1600hrs Oct. 2, 2015 and end at 1530hrs Oct. 4, 2015

# 2. <u>MISSION</u>

a. To instruct the basic principles of an emergency survival situation. Participation in this exercise will cover all mandatory and some complimentary training for level 1.

### 3. <u>EXECUTION</u>

This exercise will take place as follows:

### a. General Outline

This will take place in five phases:

- i. Phase 1 (1100hrs 2 Oct 15) advance party begins
- ii. Phase 2 (1730hrs 2 Oct 15) Cadets will arrive at Brigadier Murphy Armoury.
- iii. Phase 3 (2000hrs, 2 Oct 0900hrs 4 Oct 15) Cadets will arrive at Cottonwood Beach; training commences.
- iv. Phase 4 (0900hrs, 4 Oct 15) Tear down and pack up.
- v. Phase 5 (1200hrs, 4 Oct 15) Departure of advance party and Cadets.

# b. Groupings and Tasks

# j. <u>Environmental Protection:</u>

i. In Case of ANY fuel or oil spills, the OPI must be notified. A spill it will be used for any fuel or oil spills. OPI will then follow the TREES program for reporting the spill. No trees will be cut down or damaged during the FTX.

# k. Garbage:

i. Will be collected during the training and properly disposed of after training.

### l. Evacuation Plan:

i. All cadets will be briefed on the evacuation plan. The meeting point due to emergency will be the designated during briefing. Initiated by the fire alarm or shouting "FIRE, FIRE, FIRE."

### m. Fire Plan:

i. In case of a fire cadets will go to the meeting spot in the evacuation plan. Cadets will report all fires. Cadets will not attempt to put out fires.

## n. <u>Medical Emergency:</u>

i. The First Aid O will treat all medical issues. The First Aid O will drive any injuries that they cannot treat to the Vernon General Hospital 1hr 6min away. Transport will be by the safety vehicle driven by the First Aid O.



### **EMERGENCY PROCEDURES**

- 1. The following injury Emergency Procedures are to be followed:
  - a. Minor injury cadet can remain
    - (1) Ensure individual and group safety first and foremost
    - (2) Conduct initial assessment, provide temporary treatment/relief (if trained) AND simultaneously notify/send for the First Aid Officer
    - (3) First Aid Officer will inspect initial treatment (if any) and modify or replace as necessary
    - (4) Parents will be contacted if necessary
    - (5) First Aid Officer will complete the necessary reporting paperwork (Cadet DND 2299, Staff CF 98)
    - (6) First Aid Officer will monitor the subject's condition continually throughout the remainder of training
    - (7) OIC Ex and CO will be notified as soon as practicable
  - b. Minor injury cadet requires hospital
    - (1) Ensure individual and group safety first and foremost
    - (2) Conduct initial assessment, provide temporary treatment/relief (if trained) AND simultaneously notify/send for the First Aid Officer
    - (3) First Aid Officer will inspect initial treatment (if any) and modify or replace as necessary
    - (4) Cadet will be removed from training area via safety vehicle or ambulance. Directions to nearest hospital above.
    - (5) First Aid O will accompany cadet and report back to OIC Ex
    - (6) Parents will be contacted by an officer

- (7) First Aid Officer will complete the necessary reporting paperwork (Cadet DND 2299, Staff CF 98)
- (8) Emergency services may be contacted if required via numbers at Command and Signals
- (9) CO will be notified as soon as practicable
- c. Major injury cadet requires hospital/emergency services
  - (1) Ensure individual and group safety first and foremost
  - (2) Conduct initial assessment, provide temporary treatment/relief (if trained) AND simultaneously notify/send for the First Aid Officer
  - (3) First Aid Officer will inspect initial treatment (if any) and modify or replace as necessary. First Aid Officer will send for emergency services as required. Emergency phone numbers at Command and Signals.

Cadet will be removed from training area via safety vehicle, ambulance, medevac, or other

- (4) First Aid O will accompany and report back to OIC Ex
- (5) Parents will be contacted by an officer
- (6) First Aid Officer will complete the necessary reporting paperwork (Cadet DND 2299, Staff CF 98)
- (7) CO will be notified as soon as practicable

#### Annex I

18 Jan 15 Safety Procedures

### **SAFETY PROCEDURES**

- 1. The following general safety procedures are to be strictly enforced:
  - a. All exercise personnel shall participate in an exercise briefing as well as an expedition briefing to be conduct by the OIC Ex prior to undertaking exercise/expedition activities,
  - b. All participants shall be aware of and adhere to safety boundaries and restricted areas.
  - c. Regular hydration of all personnel will be monitored, enforced, and initiated by exercise staff,
  - d. Appropriate hygiene practices (brushing teeth, applying deodorant, changing clothes, hand washing etc) will be monitored, enforced, and initiated by exercise staff,
  - e. Proper footwear and personal feet conditions will be verified and monitored on a continual basis,
  - f. An adult staff member to cadet ratio of 1:10 (including one staff member of each gender) will be enforced at all times,
  - g. Incidents where cadets are on roadways or in parking lots will be minimized and, if unavoidable, cadets shall wear visibility vests,
  - h. Headdress will be worn at all times by all personnel,
  - i. Rations will only be consumed at the pre-designated times in designated areas,
  - j. All garbage will be packed out by personnel.
  - k. Personnel shall not run except for in the event of an emergency or directed otherwise.
  - 1. Exercise participants shall ensure proper stretching precautions prior to commencing a hike,
  - m. Training areas will be inspected by the OIC Ex for potential safety hazards,

- n. In the event of 3 whistle or horn blasts, personnel shall proceed to the previously designated muster points.
- 2. The following work safety procedures are to be strictly enforced:
  - a. Flammable liquids will be properly stored within the POL and equipment requiring filling will only be filled within the designated area and with extreme care,
  - b. Spill kits will be carried in each DND rental vehicle and staff members will be previously trained with their use,
  - c. Knives and multi tools will only be unsheathed when required, and should be used with extreme care. Cadets will be briefed by an officer prior to using a knife or multi tool. Blades will not exceed 6 inches in length,
  - d. Safety equipment (goggles, work gloves, face masks etc) shall be available and used by personnel performing hazardous tasks,
  - e. WHMIS guidelines shall be followed by all personnel using hazardous chemicals/substances,
  - f. Personnel unsure of proper safety procedures regarding the use of tools/equipment will seek proper training prior to engaging in such activities, and
  - g. Cadets shall not use axes or hatchets unless briefed and supervised by an officer

## FIRE REGULATIONS

### 1. Fire Regulations:

- a. Fires may only be lit if and when authorized by OIC Ex,
- b. Extreme care shall be taken to ensure that stoves are operated safely and with minimal risk of spread of flame, and
- c. Matches and lighters will only be used for the legitimate lighting of cooking stoves.

### 2. Fire Fighting:

- a. Fire pickets are to be established during night with personnel to be on the lookout for fires
- b. Any individual encountering a fire shall shout "FIRE, FIRE, FIRE" and transmit "NO DUFF, FIRE, FIRE, FIRE" over the radio communications.
- c. Cadets shall be immediately directed away from the danger area to the muster point,
- d. If there is minimal risk of injury, adult staff may attempt to extinguish the fire,
- e. An adult staff member will conduct a roll call to ensure that all personnel area accounted for,
- f. OIC Ex will contact emergency services as per Command and Signals, and
- g. Arrangements shall be made to evacuate cadets or continue the activity without exposing cadets to fire damaged area.

### ENVIRONMENTAL PROCEDURES

- 1. All personnel are to act with due diligence to ensure minimal impact on the environment by abiding to the following:
  - a. Every effort shall be made by personnel to ensure minimal impact to the environment,
  - b. All garbage will be collected and carried out by participants,
  - c. When possible, recycling shall be separated from garbage and properly disposed of,
  - d. Spill kits will be carried in each DND rental vehicle and staff members will be previously trained with their use,
  - e. Live trees, brush, plants, etc shall not be removed or disturbed and holes shall not be dug,
  - f. Personnel shall only hike on pre-laid trails and will minimize any deviations from the path,
  - g. Personnel shall use washroom facilities every time they are required, and
  - h. Grey water shall be disposed of in the provided washroom facilities.
- 2. In the event of a spill:
  - a. Trained personnel shall take control of the situation,
  - b. Spilled chemicals and contaminated surfaces shall be removed or absorbed as per TREEs training guidelines, and
- c. The incident shall be properly reported through the chain of command
